

8. any therapeutic device or appliance, including syringes (but excluding insulin syringes), support garments, prostheses and contraceptive devices or materials, regardless of their intended use;
9. any immunization agent, biological serum, blood or blood plasma;
10. any drug, prescription or otherwise, used to eliminate baldness;
11. oral contraceptives used for birth control;
12. any drug, prescription or otherwise, used for the treatment of nicotine addiction.

Any prescription drug covered under this Plan will not be covered under the Medical Expense Benefit.

13. for expenses incurred directly or indirectly as the result of an abortion except when the life of the mother would be threatened if the fetus were carried to term, when complications arise, or when the pregnancy is the result of rape or incest;
14. for injury sustained or sickness contracted while committing or attempting to commit suicide, while sane or insane;
15. for any intentionally self-inflicted injury or sickness, while sane or insane;
16. for injury sustained or sickness contracted while committing or attempting to commit an assault or felony;
17. for services performed by a physician or other professional provider enrolled in an education or training program when such services are related to the education or training program;
18. for the services of any person who is a member of the covered person's immediate family consisting of the covered person, spouse, child(ren), brothers, sisters or parents or a family member who resides in the covered person's home;
19. for expenses related to artificial reproductive procedures, including but not limited to artificial insemination, in vitro fertilization, surrogate mother, fertility drugs when used for treatment of infertility, drugs and devices used for contraception, reversal of a sterilization operation, a sex change operation, or treatment of sexual dysfunction not related to organic disease;
20. for wigs, artificial hair pieces, human or artificial hair transplants, or any drug -- prescription or otherwise -- used to eliminate baldness.  

This provision does not apply when baldness is a result of chemotherapy, radiation therapy or surgery. Under these conditions, purchase of a wig or artificial hair piece is limited to one per lifetime;
21. for injury sustained or sickness contracted while on active duty in military service;
22. for injury sustained or sickness contracted as the result of or caused by any act of war, or participation in a riot or civil disobedience;
23. for any expenses incurred as a result of or in connection with treatment that is experimental/investigative in nature or for experimental drugs or experimental drug usage;
24. for supportive devices for the feet and for orthopedic shoes, unless they are an integral part of a leg brace and the cost is included in the orthotist's charge;

**THIS IS IMPORTANT TO YOU** - Please keep attached to your InVision Technologies Employee Benefit Plan Booklet.

This Endorsement amends your Employee Benefit Plan **effective January 1, 1997** as follows:

**Page 34:** Delete 13) and replace it with the following:

- 13) for expenses incurred directly or indirectly as the result of an abortion. .  
This exclusion applies to all abortion services including those performed when the covered person's health is placed in permanent jeopardy;

All other terms of the Employee Benefit Plan remain the same.
